PRESS RELEASE FROM HON'BLE CHIEF MINISTER, WEST BENGAL

In view of the evolving situation on the spread of Novel Corona virus (COVID - 19), the advisories issued by WHO, UN and Central Government and as a matter of abundant precaution to check its spread in the State of West Bengal, it has been decided that all Government, Government-aided, private educational institutions - Schools, Colleges, Universities, Madrasahs, SSK/MSK will remain closed from 16 March, 2020 to 31 March, 2020 in public interest. The internal examinations of these institutions will also remain suspended during the said duration.
