With reference to your proposal on the above subjects, I am directed to inform you that considering the Memo No. JS-Affi (BU)/52/SCHE/2016 dated 15.03.2016 issued by the Joint Secretary, W.B. State Council of Higher Education addressed to the Inspector of Colleges, The University of Burdwan and on the basis of the recommendation of the Inspecting Team of this University, the Vice Chancellor has been pleased to grant extension of affiliation to Panchmura Mahavidyalaya, Bankura in the Under Graduate Courses in Physics (Hons.), Environment Science (G) and Computer Science (G) with effect from the Academic Session 2017-18 subject to fulfilment of the following terms and conditions laid down by the University below:

- 1. Intake to students for the courses offered: Physics (Hons.)-20 Environment Science (G) -30
 - Computer Science (G)-30
- 2. Representation of the college on different Boards, participation in the examination process shall be in accordance with the rules, procedure as prescribed by the University in this respect.
- 3. Fee structure of the Courses will be determined by the college in consultation with the University.
- 4. The college authority may engage one full time teacher in Physics (Hons.) and two part time teachers each of Environment Science (G) and Computer Science (G).
- 5. One Laboratory Attendant for each Department may be engaged for the smooth running of
- 6. Adequate infrastructural facilities including a book grant to the tune of Rs. 1, 00,000/- be provided to Physics (Hons.) and Rs. 50,000/- each for Environment Science (G) and Computer Science (G).

With reference to your proposal on the above subjects, I am directed to inform you that considering the Memo No. JS/Affi(BANK)/168/WBSCHE/2018 dated 11.06.2018 and the Memo No. MS/Affi(BANK)/169/SCHE/2018 dated 11.06.2018 issued by the Joint Secretary, W.B. State Council of Higher Education addressed to the Inspector of Colleges, Bankura University and on the basis of the recommendation of the Inspecting Team of this University, the Vice Chancellor has been pleased to grant extension of affiliation to Panchmura College, Bankura in the Under Graduate Courses in Geography (H), Education (H), Environmental Science (H) and Computer Science (H) and the Post Graduate courses in Bengali, Mathematics and History with effect from the academic session 2018-2019. subject to fulfilment of the following terms and conditions laid down by the University below:

1. Intake of students for the courses offered:

Geography (H)- 20 Education (H)- 30 Environmental Science (H)- 20 Computer Science (H)- 20 Bengali (PG)- 25 Mathematics (PG)- 20 History (PG)- 20

- 2. Representation of the college on different Boards and participation in the examination process shall be in accordance with the rules and procedures as prescribed by the University in this respect.
- 3. Fee structure of the Courses will be determined by the college in consultation with the University.
- 4. The college authority may engage 01(one) Contractual Whole Time Teacher (CWTT) for each Geography(H), Education(H) and Environmental Science (H) Department and 02(two) Contractual Whole Time Teacher (CWTT) for Computer Science (H) Department. 01(one)

- Guest Teacher may be engaged for each Geography(H) and Environmental Science (H) Department.
- 5. 01 (one) Laboratory Attendant for each Geography(H), Environmental Science (H) and Computer Science (H) Department may be engaged for the smooth running of the Laboratories.
- 6. One dedicated Laboratory may be reserved for each Geography(H), Environmental Science (H) Computer Science (H) and Mathematics(PG) Department for conducting the practical classes of respective Departments.
- 7. Laboratory Equipment worth Rs. 3,00,000/- may be procured for each in Geography(H), Environmental Science (H) and Computer Science (H) Department.
- 8. Adequate infrastructural facilities including a book grant to the tune of Rs. 1, 00,000/- each be provided to the above-mentioned subjects.
- 9. For holding the classes of the Course offered two rooms each of every subject shall have to be provided by the college.
- 10. The College authority will make necessary arrangements from their own resources for providing instructional and infrastructural facilities and uplift of the existing ones including installation of fire fighting apparatus etc. in keeping with the requirement as per norms/regulations/guidelines etc. of the related regulatory bodies including the government in the Higher Education Department presently in vogue and as will be amended from time to time.
- 11. Engagement of required number of faculty members and / or Guest Faculty is to be arranged by the college concerned and the expenditure arising out of the exercise taken in this regard is to be borne by the college out of its own resources. Considering the socio-economic background of this area, recommendations in relation to the above mentioned subjects, are made on Non Self-financing basis except Computer Science(H) and no additional financial implication should come on H.E department for at least three years.
- 12. The College authority will furnish before the University a declaration for giving strict adherence to the conditions as laid down serial no. 4 and 5.
- 13. The Principal of the College shall have to take immediate steps to appoint teachers of the subjects mentioned above.
- 14. For holding the classes of the Course offered two rooms each of every subject shall have to be provided by the college.
